# Trauma theory, racism and gender studies, modern medievalism

My work generally focuses on the intersection of medieval literature and the construction of religious identity, and combines literary and historical analysis.

- Dissertation: "Haunted by Heresy: The Perlesvaus, Medieval Antisemitism, and the Albigensian Crusade"

Based on close reading and intertextual analysis across several genres, this study interprets the hyper-violent, phantasmagorical *Perlesvaus* (an anonymous, thirteenth-century Old French Grail romance) as a profoundly significant work of "trauma fiction" encoding a hitherto-unrecognized crisis of religious ethics and identity in the West tied to the brutal onset of internal crusading. Among its broader implications is the new light it sheds on worsening medieval antisemitism.

• This substantial paper presents a revolutionary new reading of the Oxford *Roland* as a theologically inflected text addressed to multiple, overlapping audiences. A wide range of interdisciplinary evidence is brought to bear to situate the poem as a "literary cognate" of Abbot Suger's rhetorically sophisticated proto-Gothic building program. *Speculum* is one of the most prestigious journals in medieval studies.

## SUBMITTED ARTICLES

"Wandering Christian: Ritual Cannibalism and the 'Doppelganger Jew' in the *Book of John Mandeville*" (Manuscript 44 pages)

• This paper begins by examining the shifting treatment of Eastern cannibalism within a particular Middle English version of the "Mandeville multitext" and then gradually widens the analytic lens, exploring how fears over Jewish/Christian category collapse encoded in the *Book's* discourse of cannibalism can shed new light on longstanding issues in Mandeville criticism as well as on the ugly evolution of Western antisemitism. It concludes with the claim that the "doppelganger Jew" whose presence presides over this late-medieval pilgrimage guideturned-world travelogue has the potential to elucidate moments of burgeoning anti-Jewish racism across a wide range of texts and historical settings.
